Boswellia serrata Extract (40% Boswellic Acid)

- Gum resin from the boswellia serrata tree is used to treat various chronic inflammatory diseases†
- Helps prevent the formation of leukotrienes (inflammatory markers)†

DL-Phenylalanine

- May promote higher levels of certain endorphins, thereby calming stressed muscles and joints†
- Promotes mental functioning†

MSM (Methylsulfonylmethane)

- An organic sulfur compound
- Relieves joint and muscle pain, swelling, and stiffness by reducing inflammation†
- Preserves cartilage†

Collagen (Type II)

- The primary form of collagen contained in cartilage†
- Aids in reducing joint pain†

DGL (Deglycyrrhizinated Licorice Root)

- An extract of licorice root
- Promotes healing of mucus membranes in the digestive tract†

BioPerine® (Black Pepper Fruit Extract)

- An extract (piperine) derived from black pepper
- Clinically shown to enhance the absorption of Turmeric, as well as other vitamins, minerals, and botanicals
